CONTRIBUTIONS OF PUBLICATIONS TO KNOWLEDGE

My research focus and contributions to knowledge are primarily in the area of indigenous housing sustainability of Nigerian people. It discusses history of traditional architecture, culture, forms, pattern, ancient technology and socio-cultural attainment of people in the past to the present. I use my knowledge to appraise the indigenous motifs of buildings material, forms, pattern and durability as subject of assessment. Recognising that despite formal architectural training in the use of modern and foreign methods of construction techniques, styles, materials, Nigerian architects are always inspired by indigenous and socio-cultural lifestyle of their people and immediate environment in resolving housing issue.

My initial interest in the concept of indigenous buildings was informed by the choice of architects using indigenous lifestyles in their design and construction. My works identifies relationship between architecture and culture of the people as the basis for technology growth in the society. It traces the development of technology and inventions to traditional architecture and indigenous construction methods and buildings developed during Stone Age, contemporary time and skyscrapers. In respect to this, my First- and Second-degree thesis projects explored the appreciation of traditional building using Ado-Ekiti Oba's palace as a case study and Idanre hill tourist centre using natural features to achieve conducive tourist environs, where I used notable and seasoned architectural edifice through ages in Nigeria and abroad as my case study.

Currently, my works take cognisance of the vulnerability of most Nigerian traditional housing and indigenous life-style going towards extinction. This idea gave birth to the concept of my PhD thesis where I embarked on research in evaluation of housing quality in the traditional core area of Ado-Ekiti, Nigerian. The research identifies housing quality as a key determinant of a person's quality of life, which in turn is used to evaluate the general well-being of such individual in the society. It investigates housing quality in terms of the quality of design,

building materials, standard of construction, its immediate surrounding including infrastructure

and facilities. The research observes challenges in the residents' socio-economic

characteristics, dwellings' physical characteristics, neighbourhood factors, provisions and

maintenance of the existing social amenities impacted on the housing quality in the area of

study. The research recommended that government should invest more in improving the

overall traditional core area of city, as this will lead to improved lives, and the overall quality

and experience of its inhabitants. The study also recommend that buildings owners should be

trained in making use of available rural resources in conjunction with modern facilities in

maintaining and building quality houses in Nigeria and in the study area in particular.

I have also collaborated with colleagues in other sections of architecture, as well as other fields

of study to carry out researches. These collaborations have resulted into publications in the

area like structure, geology, ceramics, architecture, graphic, construction management,

building, estate management, urban planning and housing sustainability. Finally, my research

is making clear statement on the need to preserve traditional and modern buildings for future

reference. My works recommend the use of quality and durable building materials for

construction of sustainable building because all contemporary buildings will certainly become

antiquity in the space of hundred years and above, if they are properly preserved.
